

The purpose of this modification is to incorporate Approved Funding Program (AFP) number 5, incorporate Provisional Work Authorization Directives, and make an administrative correction to Modification A002.

Contract No. DE-AC08-01NV12101 is hereby modified as follows:

1. Clause B.3, ESTIMATED COST AND FEE paragraph (b), is revised to reflect a net decrease in estimated cost of \$31,461,000, due to WADs YMP0011 Rev 00, WAS0011 Rev 00, PMA0011 Rev 00, HRA0011 Rev 00, MD10011 Rev 00, and QA00011 Rev 00, in the amount of \$147,297,000, and inter/intra office transfers of (\$4,639,000), which appears on Approved Funding Program (AFP) number 5 of fiscal year 2001.
2. As a result of the aforementioned revisions, and transition costs per Clause B.3, ESTIMATED COST AND FEE, paragraph (a)(1), there is a net decrease in the estimated cost of \$21,708,000. Therefore, the estimated cost for fiscal year 2001 is revised from \$174,119,000 to \$152,411,000.

Accordingly, Clause B.3 is revised as follows:

3. This modification implements changes in contract funding pursuant to AFP number 5 for fiscal year 2001. AFP number 5 appears as Attachment 1 to this modification. The AFP stipulates the appropriate budget and reporting code distribution of the incremental funding identified below. The following is a summary of funding changes in AFP number 5:

In accordance with changes in AFP number 5, funds in the amount of \$6,498,000 are hereby obligated to the contract. The total amount of obligated funds from contract inception-to-date is therefore increased from \$108,677,000 by \$6,498,000 to \$115,175,000. Therefore, Clause B.2, OBLIGATION OF FUNDS, is revised to read as follows:

Pursuant to the clause entitled ,'Obligation of Funds', total funds in the amount of \$115,175,000 have been allotted for obligation and are available for payment of allowable costs and any fees to be incurred from the effective date of this contract through the period estimated to end March 31, 2006.

4. In the purpose statement of Modification A002, delete the reference to a change to contract number.

5. Except as provided herein, all terms and conditions of the document referenced in 10A of the Standard Form 30, as heretofore changed, remain unchanged and in full force and effect.
