The following are my preliminary comments on Yucca Mountain:

- 1) I just received the Prel. Site Suitability Evaluation Report on August 29. I previously request to be added to the mailing list but had to request a copy of this critical report. One week to review this report with all its cross referencing is not adequate for the public review process; therefore, I request that the comment period be extended another 90 day for my detail review.
- 2) There should be final set of Public Hearings after the Final Environmental and other critical reports are issued. There are many unanswered comments and questions to date and the Public should have an opportunity to comment after DOE further defines this project.
- 3) The hearings on 9/12 and 9/13 should also be broadcast live via the Internet as is planned for the 9/5 hearings. We hear in the Las Vegas Valley should be given an easy way of learning about these communities

concerns without driving to the hearing.

4) The Public involvement in the Yucca Mountain Suitability Evaluation should not be prematurely cut stop for the convince of an artificial schedule constraint. Full and meaningful public involvement in the suitability process is needed to correctly solve this nations High Level Nuclear Waste Problem.

5) Because of the multiple daily shipments of Nuclear Spent Fuel to the proposed repository, the TRANSPORTATION Methodology and Program for the 30 years of ships need to be addressed. The transportation routes, methods, frequencies and other critical issues must be designed now and their environment impact must be addressed for the primary and alternatives routes. The issues of security, terrorism, accidents and other critical issues need to be addressed now!

The major Environment Impacts on the American Public will be the Transportation of the Nuclear waste across the Untied States.

The DOE needs to immediately work with the other Government agencies involved with the Transportation. Who is the Lead Governmental Agency for the Transportation? The DOE is being deficient in its duty not comprehensively addressing the Transportation.

Yucca Mountain as a Nuclear Waste Storage Facility will not be Suitable, if the Nuclear Waste cannot to safely ship into and through Nevada. The complete process is flawed by not addressing the major Environment Impact!

6) Yucca Mountain is turning into an Engineer Storage Concept Vs the Geologic Storage Concept envisioned the initiating ACT. Justification for the change in Concepts need to be address. How does the current design satisfy the intent of the Congressional directive.

7) Considering that the proposed Energy Policy calls for additional use of Nuclear Power, a projection of the additional nuclear waste needs to be developed and alternative of how to handle these wastes be proposed. What is the Design Maximum Storage of Nuclear Waste for Yucca Mountain?

Please address the above comment and extent the comment period by another 90 days after all Final Reports are issued and the Thirty-Year Transportation Program is adequately covered. Henry Dziegiel
